

**FORM 10 – ESCAPE/INTRUSION REPORT  
CHRONIC WASTING DISEASE HERD CERTIFICATION PROGRAM**

Owners/cervid farm operators are responsible for reporting to the status assessor and appropriate provincial/territorial Ministry any cervids that have escaped and the intrusion of wild cervids into the premises immediately, or with reasonable promptness. The following report is to be submitted immediately with each case of an escape or intrusion, and the total number of cases reported included in the annual *Form 11 – Biosecurity Assessment*. An instance of a group escape or intrusion can be reported as a single event, however all cervids implicated in a group report will be subject to the same risk assessment.

**Escaped cervids**
